



RDMS A – PRIIPs Monthly Scenario Report

Frequency: DAILY | RHP: 3 years

This report presents monthly evaluations of PRIIPs scenario metrics for RDMS. Each section includes:

- PnL and Annualized Return under different market conditions (Favorable, Moderate, Unfavorable, Stress)
- VEV (VaR-equivalent Volatility) and SRI

These scenarios are computed using historical fund returns and benchmark proxies, following PRIIPs methodology.

RHP: refers to Recommended Holding Period.

This table shows the money you could get back over the next years, under different scenarios, assuming that you invest the reference amount.

The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products.
