

RGBI C – PRIIPs Monthly Scenario Report

Frequency: DAILY | RHP: 5 years

This report presents monthly evaluations of PRIIPs scenario metrics for RGBI. Each section includes:

- PnL and Annualized Return under different market conditions (Favorable, Moderate, Unfavorable, Stress)
- VEV (VaR-equivalent Volatitity) and SRI

These scenarios are computed using historical fund returns and benchmark proxies, following PRIIPs methodology.

RHP: refers to Recommended Holding Period.

This table shows the money you could get back over the next years, under different scenarios, assuming that you invest the reference amount.
