Strategies fall under the following buckets: Arbitrage/Market Making, Statistical Arbitrage/Relative Value, Trend capture/Mean rev,Hybrid and DeFi.

The fund targets annual returns of 15% with a volatility below 12% that are uncorrelated with BTC.

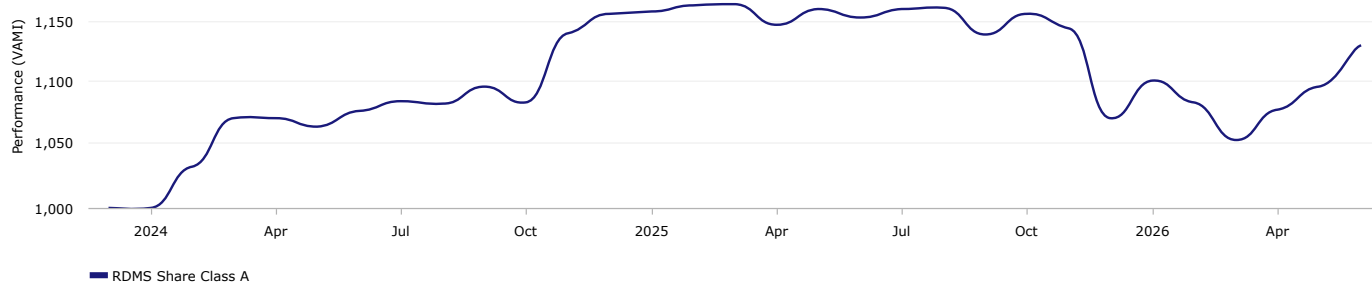

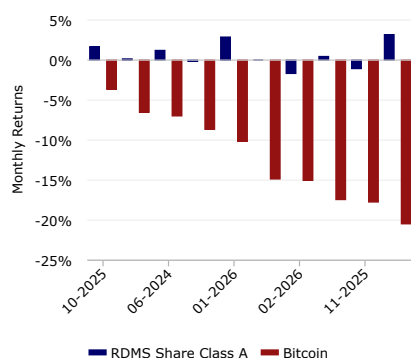

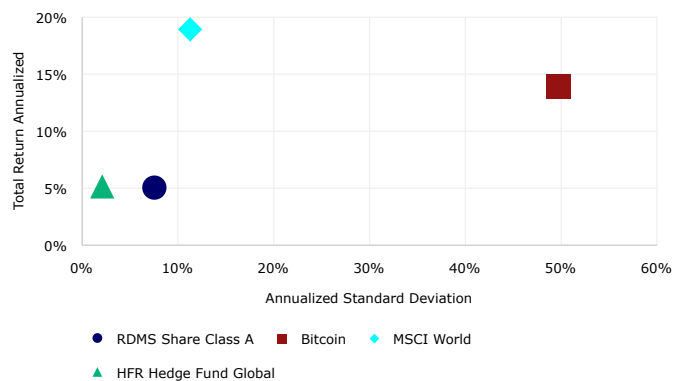

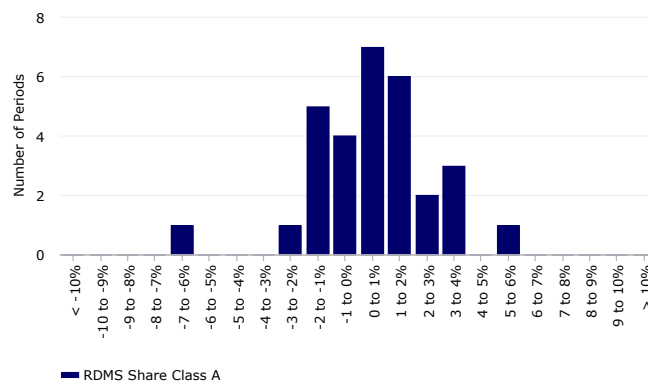
